## **EXECUTIVE SUMMARY**

Hearing activity increased significantly in fiscal 2020-21 as compared to the prior year despite the Tribunal transitioning to virtual hearings because of the pandemic. There were 126 calendar days on which at least one oral hearing was scheduled, which represents an increase of 35% from the prior year, and 190 oral hearings scheduled that proceeded, which represents an increase of 50% from the prior year. The number of oral hearings scheduled is greater than the number of calendar days because multiple hearings may occur on the same calendar day.

In addition to oral hearings, the Tribunal considered 47 written hearings, compared to 45 written hearings the prior year.

Although the total number of applications commenced in fiscal 2020-21 declined, the number of active applications increased in every quarter. As at the end of the fourth quarter, there were 28 active applications, which represents a 47% increase from the same quarter of the prior year. Of these 28 active applications, 15 or 53% were over 12 months old with an average age of 716 days.





#### YEAR OVER YEAR COMPARISON – WRITTEN HEARINGS SCHEDULED BY TYPE



#### YEAR OVER YEAR COMPARISON – CALENDAR DAYS



#### YEAR OVER YEAR COMPARISON - SETTLEMENTS



#### YEAR OVER YEAR COMPARISON – ORDERS ISSUED


