EXECUTIVE SUMMARY

The number of proceedings commenced in fiscal 2021-22 declined, due in part to a 54% decrease in the number of applications for authorization to disclose.

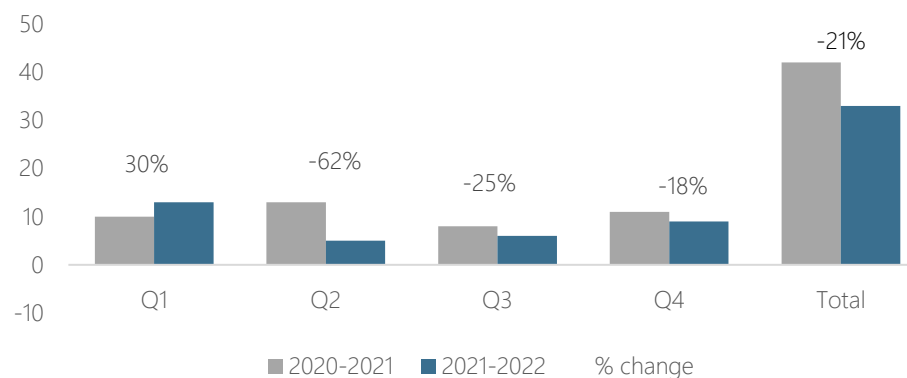
Hearing activity decreased in fiscal 2021-22 compared to the prior fiscal year. There were 96 calendar days on which at least one oral hearing was scheduled, or a decrease of 26% from the prior fiscal year, and 121 oral hearings scheduled that proceeded, or a decrease of 36% from the prior year. The number of oral hearings scheduled is greater than the number of calendar days because multiple hearings may occur on the same calendar day.

In addition to oral hearings, the Tribunal considered 37 written hearings, compared to 47 written hearings the prior fiscal year.

There were 38 active applications as at the end of the year, or a 36% increase from the prior fiscal year. Of these 38 active applications, 17 or 45% were over 12 months old, with an average age of 822 days.

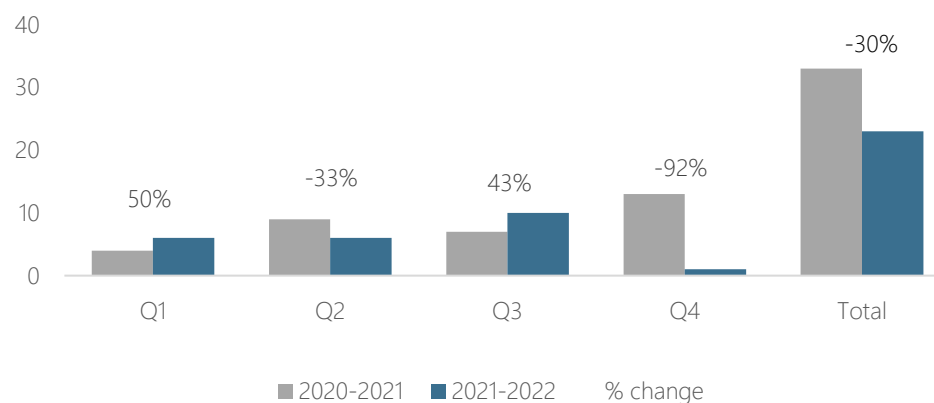

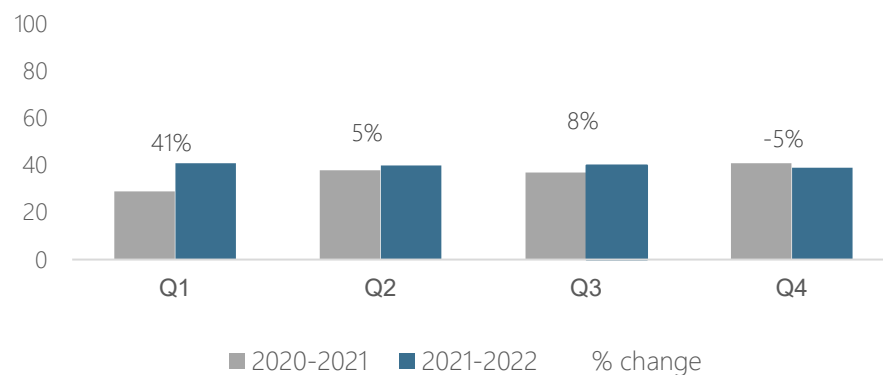
YEAR OVER YEAR COMPARISON – APPLICATIONS CLOSED

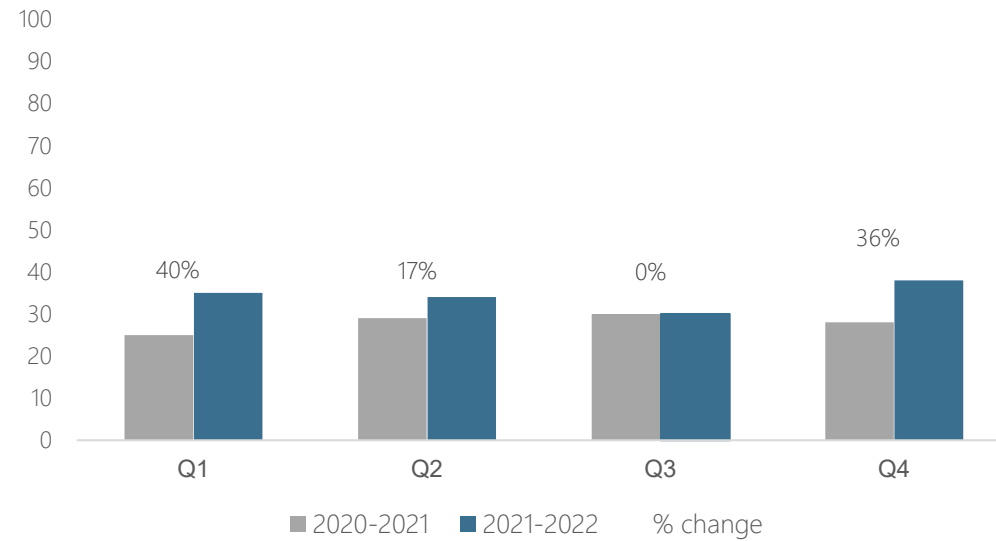
YEAR OVER YEAR COMPARISON – ACTIVE APPLICATIONS DURING THE PERIOD

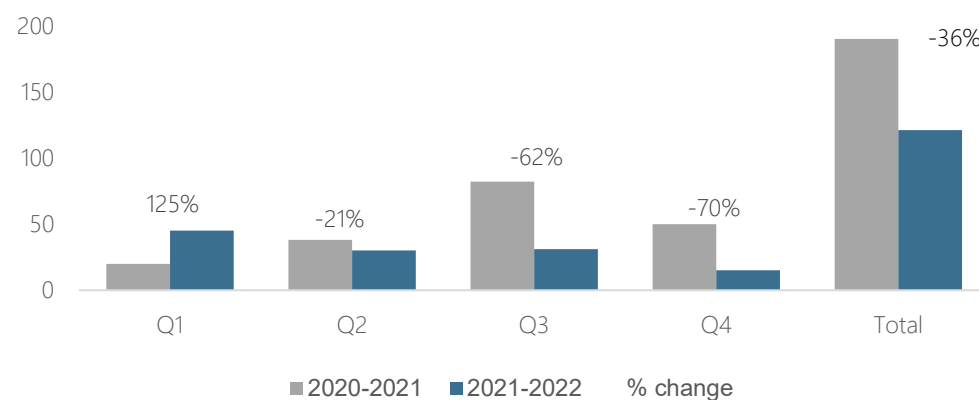

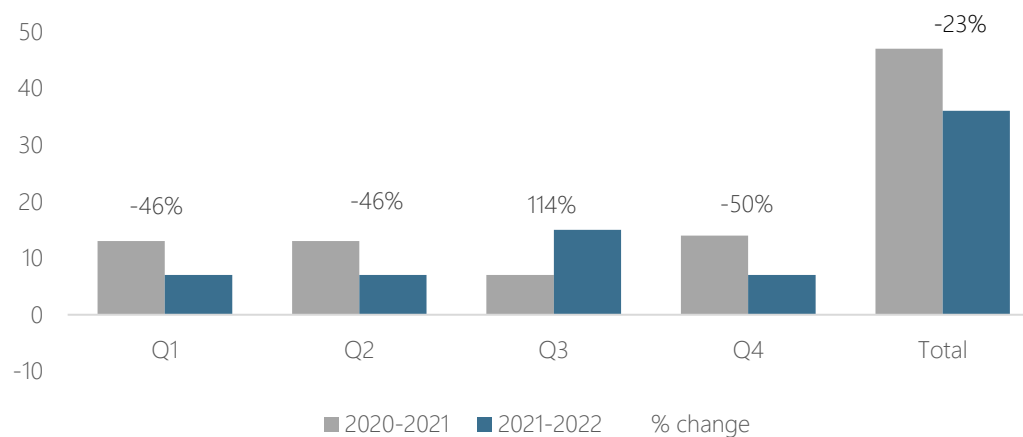
YEAR OVER YEAR COMPARISON – ORAL HEARINGS DAYS SCHEDULED

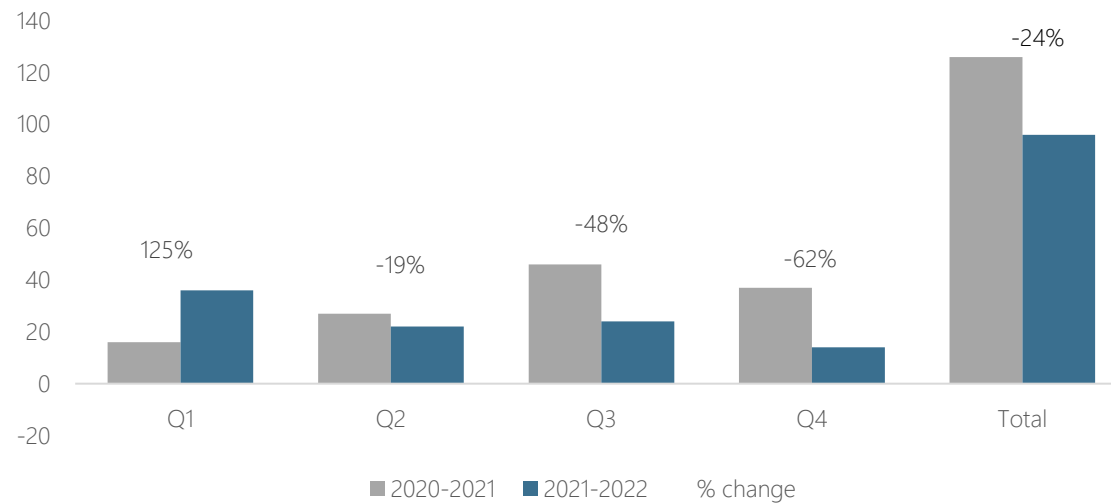
YEAR OVER YEAR COMPARISON – WRITTEN HEARINGS SCHEDULED BY TYPE

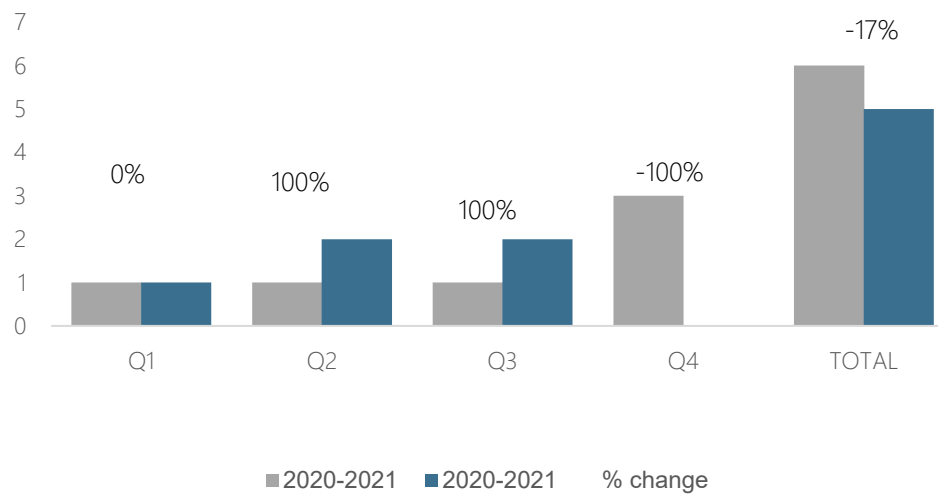
YEAR OVER YEAR COMPARISON – CALENDAR DAYS

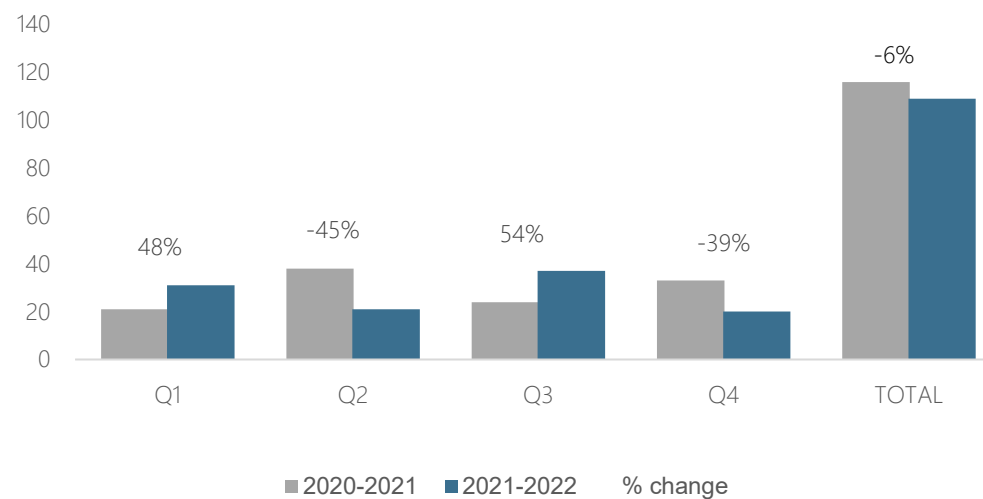
YEAR OVER YEAR COMPARISON - SETTLEMENTS

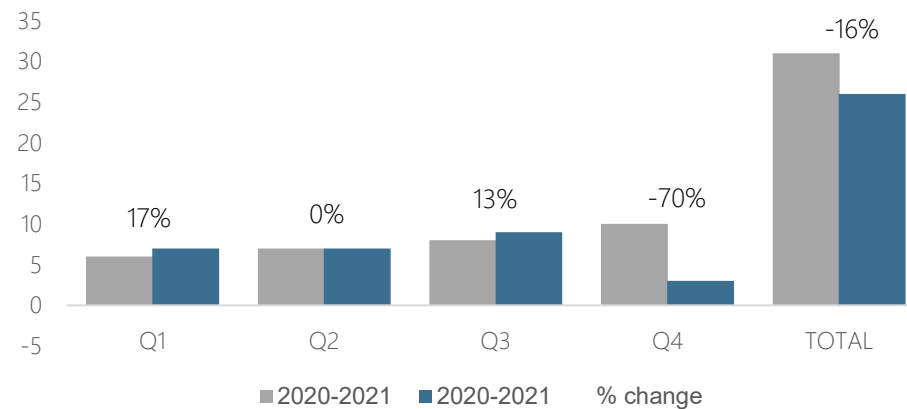
YEAR OVER YEAR COMPARISON – ORDERS ISSUED
