ORDER

(Subsections 127(1) and 127(4.0.2) of the *Securities Act*, RSO 1990, c S.5)

WHEREAS the Capital Markets Tribunal held a hearing in writing to consider an application brought by the Ontario Securities Commission for an order imposing sanctions against the respondents, Wesley William Robinson and DRR900306 NS Ltd., without giving the respondents an opportunity to be heard, pursuant to subsections 127(1) and 127(4.0.2) of the *Securities Act* (the **Act**);

ON READING the materials filed by the Commission, the Decision of the Nova Scotia Securities Commission dated August 20, 2021, the Sanctions Decision of the Nova Scotia Securities Commission dated January 6, 2022, and the Order of the Nova Scotia Securities Commission dated January 6, 2022;

IT IS ORDERED THAT:

1. Against Wesley William Robinson:
 - a) pursuant to paragraph 2 of subsection 127(1) of the Act, trading in any securities or derivatives by Robinson shall cease permanently;
 - b) pursuant to paragraph 3 of subsection 127(1) of the Act, any exemptions contained in Ontario securities law do not apply to Robinson permanently;
 - c) pursuant to paragraphs 8, 8.2, and 8.4 of subsection 127(1) of the Act, Robinson is permanently prohibited from becoming or acting as a

director or officer of any issuer, registrant, or investment fund manager; and

- d) pursuant to paragraph 8.5 of subsection 127(1) of the Act, Robinson is permanently prohibited from becoming or acting as a registrant, an investment fund manager or a promoter.

2. Against DRR900306 NS LTD. (DDR):

- a) pursuant to paragraph 2 of subsection 127(1) of the Act, trading in any securities or derivatives by DDR shall cease permanently;
- b) pursuant to paragraph 3 of subsection 127(1) of the Act, any exemptions contained in Ontario securities law do not apply to DDR permanently; and
- c) pursuant to paragraph 8.5 of subsection 127(1) of the Act, DDR is permanently prohibited from becoming or acting as a registrant, an investment fund manager or a promoter.
