Catalyst Fund General partner Inc.

In respect of Catalyst Fund General Partner Inc., the Commission grants modified "Torstar" standing. The Commission is of the view that it would be a useful contribution to the proceedings on the merits for Catalyst Fund General Partner Inc.'s counsel to adduce evidence only relating to:

- (i) the adequacy of the valuation by GMP Securities Ltd. of the proposed going private transaction and the adequacy of the information underlying such valuation, and
- (ii) the adequacy of the CCPR and the CCPR Trust, as defined in the Management Proxy Circular of Hollinger dated March 4, 2005.
