### SETTLEMENT AGREEMENT BETWEEN STAFF OF THE ONTARIO SECURITIES COMMISSION AND THOMAS VINCENT HINKE

#### I. INTRODUCTION

1. Pursuant to section 5(1) of the "Practice Guidelines - Settlement Procedures in Matters Before the Ontario Securities Commission" of the Ontario Securities Commission Rules of Practice, Staff of the Ontario Securities Commission and Thomas Vincent Hinke propose to settle the matters described further below.

#### II. STATEMENT OF FACTS

### Acknowledgement

2. Hinke acknowledges that the facts set out in paragraphs 3 through 12 of this Settlement Agreement are correct.

#### Facts

- 3. Hinke is an individual residing in Ontario. During the period between December, 1996 and December, 2000 (the "Material Period"), Hinke was the President and Chief Executive Officer of Thermal Energy International Inc. ("TEI").
- 4. TEI was incorporated pursuant to the laws of Ontario and is a reporting issuer, as that term is defined in the *Securities Act* (the "Act").
- 5. During the Material Period, Hinke was an insider of a reporting issuer by virtue of his position as an officer and director of TEI and by virtue his ownership or beneficial control of more than 10% of the issued and outstanding voting shares of TEI.
- 6. During the Material Period, Hinke held over 20% of TEI's issued and outstanding common shares.

- 7. Hinke filed a notice of intent to sell 100,000 shares of TEI, pursuant to section 72(7) of the Act, dated October 15, 1997.
- 8. During the Material Period, Hinke carried out transactions in TEI shares, as listed in Schedule "A" to this Settlement Agreement, and failed to file insider reports reflecting these transactions, as required by section 107 of the Act.
- 9. During the Material Period, Hinke carried out transactions in TEI shares, as listed in Schedule "B" to this Settlement Agreement, and such transactions constituted a distribution of the securities of TEI. These distributions were not conducted pursuant to a prospectus, as required by section 53(1) of the Act.
- 10. Hinke made voluntary disclosure of all of the facts described above to Staff.
- 11. Hinke co-operated with Staff in its investigation of this matter.
- 12. Since December of 2000, Hinke has made all required regulatory filings regarding his transactions in TEI shares.

#### **Hinke's Conduct**

13. Hinke's conduct, as described above, contravened Ontario securities law and was contrary to the public interest.

#### III. TERMS OF SETTLEMENT

- 14. Hinke agrees to the following terms of settlement:
  - (a) he undertakes to make all future required regulatory filings regarding his transactions in TEI shares in a timely manner; and
  - (b) he will make a voluntary contribution in the amount of \$8,000.00 to the Ontario Securities Commission's Investor Education Fund on or before April 8, 2002.
- 15. Hinke agrees that he will not, in any proceeding, refer to or rely upon this Settlement Agreement, the settlement discussions/negotiations or the process of obtaining the Executive Director's consent to this Settlement Agreement as the basis for any attack on the Commission's jurisdiction, alleged bias or appearance of bias, alleged unfairness or any other remedies or challenges that may otherwise be available.

#### IV. STAFF COMMITMENT

- 16. If this settlement receives the consent of the Executive Director, Staff will not initiate any other proceeding under the Act against Hinke in relation to the facts set out in Part II of this Settlement Agreement.
- 17. If this settlement receives the consent of the Executive Director, and at any subsequent time Hinke fails to honour the undertaking contained in paragraph 14(a) of this Settlement Agreement, Staff reserves the right to refer to this Settlement Agreement in any future proceeding.

#### V. APPROVAL OF SETTLEMENT

- 18. If, for any reason whatsoever, the Executive Director does not consent to this settlement:
  - (a) this Settlement Agreement and its terms, including all discussions and negotiations between Staff and Hinke leading up to the execution of this Settlement Agreement, shall be without prejudice to Staff and Hinke;
  - (b) Staff and Hinke shall be entitled to all available proceedings, remedies and challenges, including proceeding to a hearing of these matters before the Commission, unaffected by this Settlement Agreement or the settlement discussions/negotiations; and
  - (c) the terms of this Settlement Agreement will not be referred to in any subsequent proceeding, or disclosed to any person, except with the written consent of Staff and Hinke or as may be required by law.

#### VI. DISCLOSURE OF SETTLEMENT AGREEMENT

- 19. This Settlement Agreement and its terms will be treated as confidential by Staff and Hinke until consented to by the Executive Director, and forever, if for any reason whatsoever this settlement is not consented to by the Executive Director, except with the consent of Staff and Hinke, or as may be required by law.
- 20. Any obligation of confidentiality shall terminate upon receiving the Executive Director's consent to this settlement.
- 21. Staff and Hinke agree that if the Executive Director does consent to this settlement, they will not make any public statement inconsistent with this Settlement Agreement.
